I am writing on behalf of the Ashburnham Westminster Regional School District regarding the parties' agreement for settlement of your request for public funding of a privately obtained independent neuropsychological evaluation for your son, [REDACTED]. If the terms of this Agreement are acceptable to you, please sign below and please sign the duplicate of this Agreement letter, which is enclosed. After signing, please mail the original Agreements back to my office in the self-addressed stamped envelope enclosed. I will then send the originals to Kathy Veroude for her signature and then send you one fully executed original. If you prefer not to execute the Agreements by mail, you can arrange a time to meet with Kathy Veroude to sign the Agreements with her or you can arrange a time to bring her the two Agreements with your signatures so that she can sign them and give you one fully executed original.

In order to settle this matter, Ashburnham Westminster (the District) will reimburse [REDACTED] (the Parents) one thousand, eight hundred dollars (\$1,800.00) of the cost of the neuropsychological evaluation of [REDACTED] they obtained from NESCA. Payment will be made by the District to the Parents upon the District's receipt of NESCA's evaluation report and upon the District's receipt of proof of such payment by the Parents to NESCA for [REDACTED] evaluation.

This offer is for settlement purposes only and does constitute an admission by the District that such an independent evaluation was warranted or that such an amount was owed to the Parents. Additionally, this Agreement does not require the District to adopt NESCA's findings and/or recommendations. Rather, the evaluation from NESCA will be

considered at a Team meeting and its findings and recommendations will be incorporated into the student's educational plan as deemed appropriate by the Team, in accordance with state and federal law. Lastly, by signing this Agreement, the District is not prohibited from proposing its own neuropsychological evaluation of E in the future.
